To access this grade, you will need either:

- A. A relevant Level 4 qualification + 5 years relevant practice; or
- B. A relevant Level 6 qualification + currently be working in a relevant role; or
- C. A minimum of 10 years' relevant practice (via the MCIEH Experience Route Assessment).

Relevant qualifications
