Notes on admission and voting

Notice of this AGM is being made available to all members at least 21 days in advance, thus allowing at least seven days for the full* payment of all subscriptions for 2018, which must be received at Chadwick Court by 17.00 on 7 June 2018.

Voting by proxy

In accordance with the AGM Operational Procedures, members who are unable to attend the AGM may, on demand of a poll being made, record their votes for or against any particular resolution on matters appearing on the agenda for the meeting. This may be done by the appointment of a proxy, and for this purpose in connection with the AGM a form (Form V.1) has been published on the CIEH website at www.cieh.org/agm

These proxy forms must be properly completed and deposited at the registered office of CIEH not later than forty-eight hours before the meeting (i.e. 14.00 on Tuesday 19 June 2018). If these forms are not properly completed or are not received by the date and time stated, they will be rejected.

Only members in good financial standing as at 17.00 on 7 June 2018 are entitled to vote, either personally or by proxy, or as proxy for another member, and they should instruct their proxy to vote for or against any resolution as appropriate.

By rail and underground

Waterloo and Waterloo East mainline stations. (Walk Time – approximately 10 minutes)

Follow signs for the Waterloo Road/Old Vic Theatre exit. Walk down Sandell Street (past staircase exit to Waterloo East), at end of the road turn left into Cornwall Road, cross road and walk up the road. Take second right (by the cake shop) into Roupell Street. Proceed along Roupell Street to end (newsagents shop on the corner), turn left and walk up Hatfields.

 $\textbf{Southwark tube station} \ (\textbf{Walk Time-approximately 5 minutes})$

Turn right out of the main exit on to The Cut. Take second right into Hatfields.

From Blackfriars station

Follow the exit signs towards the Southbank Centre then pass under the bridge and turn left up the stairs by Doggets pub. Walk down Blackfriars Road and take the second right down Stamford St. Hatfields is the second road on your left and we are number 15, the second building on your left.

By bus

The following bus routes stop on Blackfriars Bridge: 45, 63, 100. The following bus routes stop on Stamford Street: 381, RV1 (towards London Bridge, for Covent Garden RV1 use Upper Ground stop) A large number of routes stop on Waterloo Road or just by Waterloo station.
