**The role of the environmental health profession in responding to the coronavirus (COVID-19) pandemic in 2020 provided a very public demonstration of how indispensable it is to protecting public health.**

Following a range of initiatives aimed at assisting our members and the wider environmental health community, we have continued to provide dedicated support for members this year with updates in our weekly email newsletter Member Connect and our CIEH-conversations webinar programme, as well as the introduction of training for COVID-marshals and enforcement.

We have also worked hard to ensure that the daily efforts of environmental health professionals have not been forgotten, with policy work and campaigning that has included:

- A major ongoing campaign led by CIEH, bringing together public health bodies, voluntary registers for cosmetics, industry representatives and politicians to support an amendment to the Health and Care Bill for better regulation of cosmetic treatments in England
- Running a major workforce survey of the environmental health profession and feeding results into the Cross-Government Review of Regulation
- Publishing an employer's toolkit to encourage more environmental health apprenticeships
