- Launched a leadership development programme certified by The Institute of Leadership and Management

- Created a hub of climate change resources on our website in response to findings from an environmental protection member survey

As the representative body for environmental health professionals, we have a responsibility to help grow and maintain the profession, promoting the benefits of working in environmental health to recruit the next generation of EHPs. In 2022 we launched a Student grade membership, and this year we have been developing the benefits members at the start of their career can access. Listening to members through surveys

We use member surveys to inform our work, including our policy positions. This year we ran surveys on precision breeding (genetic technology) and environmental protection, seeking to understand member attitudes on key issues. The results of the environmental protection survey, in which 73% indicated air quality to be a policy priority for CIEH, has enabled us to focus our attention on this issue with some incredible success, including:

- Taking this issue directly to Professor Sir Chris Whitty
- An agile consultation response to Defra's Draft Air Quality Strategy, despite only having a 9-day turnaround over the Easter period
- Collaboration with key partners to produce a cross-organisational consultation response, which secured us the opportunity to give oral evidence to the Environmental Audit Select Committee on Air Quality targets

Events

Throughout the year we have been busy putting on a range of events from low-cost Bitesize training sessions to two-day conferences. We offer our members a range of products and learning solutions to suit most budgets, locations and delivery preferences.

11,343 delegates at our events have been members in 2023

Amplifying member voices

Our Policy and Campaigns Advisory Panels remain the primary vehicle for members to influence, shape and direct CIEH policy development. Members have had the opportunity to be heard across various levels of government across the UK, including:

- Attending government advisory groups on Damp and Mould, UK Best Available Techniques (Defra) and Planning and Health
- Providing evidence to Select Committees for Science and Technology, Climate Change, Environment, and Infrastructure (Welsh Senedd) and Defra's Air Quality targets

We've also created opportunities for our members needs to be heard by high profile political individuals and groups, including:

- Michael Gove MP, Secretary of State for Levelling Up, Housing and Communities on reforms to the Private Rented Sector
- The Department for Levelling Up, Housing and Communities Decent Homes Standard review team
- The Cabinet Office and Defra officials on the newly published Target Operating Model for import controls

- This year we've secured interviews and appearances on high profile news outlets including Sky News, BBC News, LBC News and BBC Radio 4, covering issues including fracking, noise complaints and housing legislation
- We've also gained coverage in diverse news outlets including The Guardian, New Statesman, The Independent, The Sunday Times and Forbes
- We have secured coverage on budget day in national newspapers

Professional registration

Registration with CIEH demonstrates to employers and the general public that you are qualified and committed to ongoing competence and professionalism.

There are four pathways to becoming professionally Registered, based on your skills and career plans: Chartered Environmental Health Practitioner, Registered Environmental Health Practitioner, Registered Food Safety Practitioner and Registered Housing and Health Practitioner.

On becoming professionally Registered, you will be listed on our online Professional Register, as well as issued with digital credentials which can be used to verify your status quickly and easily.

We have a Professional Standards Framework which underpins our professional Registration pathways, providing clear expectations of those working in the profession.

Use your post-nominal letters* to proudly display your professional commitment and integrity to colleagues and employers.

- Last year we consulted with members and other stakeholders about the basic principles of what the process for achieving Chartered Status should be and established a Chartered Status Review Group
- This year we continued to consult with members on the proposal put forward, with strong levels of member engagement
- Looking forward to 2024, we will be relaunching a completely new pathway to become a Chartered EHP based on your feedback
